Answer the Following:

- On a holiday afternoon, Luna was relaxing in a park and browsing in her latest smart phone. She then used the app of Channel News91 to see the latest news. The Channel was broadcasting a latest news report that a criminal named Grocer, violet-haired and more than six feet tall, was on the loose and dangerous.

The image of Grocer on the phone screen was small and blurry. Looking up, Luna saw an unusually tall violet-haired man running on the jogging path alongside Luna, coming close. The man wore dhoti rather than exercise clothes. In a sincere belief that this man was the missing Grocer and running to flee rather than for leisure, Luna leaped from the grass and grabbed the tall man's leg, causing him to fall and break his wrist. The man - only 5'11" as it turned out - proved to be someone other than Grocer. Though he wore dhoti, he had been innocently running for exercise.

In light of the above facts, which of the following statements is most accurate? Give reasons, also explain why the other statements are not accurate with appropriate reasons.

- (A) Despite having desired a benign result, Luna had the intent to support a claim for damages by the tall man.
- (B) The tall man has a claim for damages not only against Luna but against News91.
- (C) Under the circumstances related, the contact that Luna inflicted on the tall man was not harmful.
- (D) Under the circumstances related, the contact that Luna inflicted on the tall man was accidental rather than intentional.
- (E) News91 did not apply duty of care in making the image of the criminal bold and clear.

Answer the following:

2. Xanaz Hospital Private Limited (hereinafter referred to as Xanaz) is a multi-specialty hospital with a staff of well qualified and well experienced medical professionals. Dr. Lamaz was one of the stellar cardiologists of the hospital and the hospital paid him a salary of Rs 10 lakh per month for performing critical heart surgeries and patient consultation. Xanaz entered into an agreement with another hospital named Hospicare Pvt Limited (herein after referred to as Hospicare) wherein they agree to lend Dr. Lamaz to Hospicare in exchange of Dr. Narukoo who is a famous brain surgeon on the pay roll of Hospicare. The period of exchange was from 30.09.2020 to 30.12.2020. Xanaz was to continue paying salary to Dr. Lamaz and Hospicare was to continue paying salary to Dr. Narukoo.

A critical heart patient named Mr. Gordo got hospitalized in Hospicare for treatment and surgery on 15.10.2020. Mr. Gordo was initially told by Dr. Lamaz who was at Hospicare that he would require a pacemaker implantation as his heart rate was too low. Accordingly, Mr. Gordo agreed for it and paid for the cost of pacemaker, hospitalization charges and surgery fees to Hospicare. Dr. Lamaz performed the surgery. After the surgery, Mr. Gordo started to feel sick with breathing difficulties. He complained about the same to one of the nurses who gave him an injection to ease his breathing. After administration of the injection, Mr. Gordo felt more restless and then slipped into a coma.

Mr. Gordo's family rushed to the hospital and due to non-helping attitude of Hospicare and lack of answers by Dr. Lamaz, they shifted Mr. Gordo to another hospital Daffodus wherein the doctors informed that the pacemaker was not properly implanted and it therefore impacted breathing. They also pointed out that the injection administered was only to be used after performing allergy test which was not done for Mr. Gordo and it reacted for him. It was concluded by the doctors that Mr. Gordo slipped into coma due to improper implantation of pacemaker as well as the administration of the injection. Further inquiry revealed Dr. Lamaz was using mobile phone and fighting with his wife while performing the operation. After this incident, Xanaz decided to take Dr. Lamaz off the pay roll. In the meanwhile, Mr. Gordo's wife sued Hospicare for compensation for negligence by Dr. Lamaz and the nurse who administered the injection.

In light of the above facts, decide the following:

- a. **Whether Hospicare is liable to pay compensation for negligence of Dr. Lamaz? (2.5 marks)**

 - b. **Identify if the given statement is Completely True or Completely False or Partly True and Partly False citing appropriate reasons:
Hospicare has to pay compensation for the negligence on the part of Dr. Lamaz as well as the nurse and later can claim proportionate contribution from Xanaz. (2.5 marks)**
3. Mr. Rambu placed spring guns in a wood on his ground for the protection of his garden. Mr. Sanoo with full knowledge that there are spring guns trespassed on the land of the defendant and was injured. Mr. Sanoo sued Mr. Rambu for exceeding his right of private defence and injuring Mr. Sanoo.

In light of the above facts, will Mr. Sanoo succeed in his claim? Give reasons in support of your answer. (5 Marks)
